The High Commission of India has a library consisting of a collection of over 1000 books and a number of Indian movies, documentary CDs and DVDs in English and Indian languages on arts, business, children's literature, culture, history, religion (Buddhism, Christian, Hinduism, Islam, Judaism etc.), sociology, world affairs and fiction mostly emphasizing on India. It enriches with the material of most recent information and events on India from all aspects such as politics, economic, education, socialization etc. It is the most reliable source for those in need of information or knowledge about India.

The Library is open from Monday to Thursday (2 to 4 pm) (except on holidays declared on these days). The Library is situated in the premises of the High Commission of India (Quadrant-C, 5th Floor, UN House, Somhlolo Road, Mbabane).

Terms & Conditions:

- Every application should be supported by a Guarantor.
- Annual Membership/Security Deposit of E100/- (refundable after one year of membership)
- Membership Fee/Security Deposit has to be paid through Electronic Fund Transfer (ETF) only in the High Commission Account (Name: High Commission of India: Bank: Standard Bank; Branch/Code: Mbabane-663164; Account No. 9110004379996). A proof of payment has to be submitted along with the application.
- Membership is valid for one year only, starting from the date of issue of membership card.
- Membership is required to be renewed annually.
- Applications may be submitted on any working day between **Monday and Thursday**.
- At a given time, only two books are allowed to be borrowed for a maximum of two weeks.
- Members will not be able to borrow new books until they return their overdue books.
- Books must be handled with care. Any loss or damage of books will be charged twice the cost of the book.
